A walk –in-interview will be held on 30.12.2017 from 10.30 AM onwards at National Institute of Siddha to fill up the posts of Professor/ Associate Professor/Emergency Medical Officer/Resident Medical Officer/House Officer/Medical Officer on contract basis and Yoga Experts/Varmam Expert/Dentist on part time basis. The period of contract will be one (1) year or till the posts are filled on regular basis whichever is earlier.

- (I) **Professor – 1 each in Maruthuvam, Noi Naadal, and Nanju Maruthuvam on contract basis with a consolidated pay of Rs.55,000/- per month.**

#### **Qualification & Experience required:**

- 1) Post Graduate Degree in Siddha in the concerned subject recognised under IMCC Act, 1970
- 2) Five years of teaching experience as Reader/Associate Professor in the concerned subject or 5 years Research Experience in PB –III (Rs.15,600 – 39,100) with GP Rs.7,600/- with NPA

OR

15 years of combined experience in teaching as Reader/Associate Professor/ Assistant Professor/Lecturer in the concerned subject or 15 years Research Experience in the pay scale of PB –III (Rs.15,600 -39,100) with GP of Rs. 7,600/-, Rs.6,600/- and Rs. 5,400/- with NPA respectively out of which minimum 2 years in the pay scale of PB-III (Rs.15,600-39,100) with GP Rs.7,600/- with NPA

### **Terms and conditions for appointment on contract basis**

- 1) The application form can be downloaded from our website [www.nischennai.org](http://www.nischennai.org) and the cost of application is Rs.500/-.
- 2) The filled in application along with the application cost of Rs.500/- by way of DD drawn in favour of Director, National Institute of Siddha payable at Chennai together with the self attested photocopies of the certificate/ testimonials should be submitted at the time of walk-in-interview. The candidates should report at 09.30 AM in the Admin Block of this Institute on 30.12.2017.
- 3) Original certificates to be produced at the time of interview
- 4) The appointment is purely on contract basis for a period of one year. However the appointment can be terminated at any time by Director, National Institute of Siddha. The appointee shall give at-least one month's notice for discontinuation.
- 5) The appointee shall not be entitled to any benefit like PF, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc or any other benefits as admissible to the regular Government servants. Non practicing allowance is not admissible.
- 6) The appointee shall not have any claim or right for regular appointment in the Institute.
- 7) Only consolidated salary will be admissible. No other allowances as applicable to Central Government Servants shall be admissible.
- 8) Leave is admissible as per CCS (Leave) Rules, 1972.
