- 2) Five years of teaching experience as Reader/Associate Professor in the concerned subject or 5 years Research Experience in PB –III (Rs.15,600 – 39,100) with GP Rs.7,600/- with NPA

OR

15 years combined experience in teaching as Reader/Associate Professor/Assistant Professor/Lecturer in the concerned subject or 15 years Research Experience in the pay scale of PB –III (Rs.15,600 -39,100) with GP of 7,600/-, Rs.6,600/- and Rs.5,400/- with NPA respectively out of which minimum 2 years in the pay scale of PB-III (Rs.15,600-39,100) with GP Rs.7,600/- with NPA.

- 3) Minimum five research publications indexed in index medicus or National Journals.

Terms and conditions for appointment on contract basis

- 1) The application form can be downloaded from our website www.nischennai.org and the cost of application is Rs.500/-.
- 2) The filled in application along with the application cost of Rs.500/- by way of DD drawn in favour of Director, National Institute of Siddha payable at Chennai together with the self attested photocopies of the certificate/ testimonials should be submitted at the time of walk-in-interview. The candidates should report between 9.00 AM and 11.00 AM in the Admin Block of this Institute on 10.01.2019. Those who report thereafter will not be considered.
- 3) Original certificates to be produced at the time of interview
- 4) The appointment is purely on contract basis for a period of one year. However the appointment can be terminated at any time by Director, National Institute of Siddha. The appointee shall give at-least one month's notice for discontinuation.
- 5) The appointee shall not be entitled to any benefit like PF, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc or any other benefits as admissible to the regular Government servants. Non practicing allowance is not admissible.
- 6) The appointee shall not have any claim or right for regular appointment in the Institute.
- 7) Only consolidated salary will be admissible. No other allowances as applicable to Central Government Servants shall be admissible.
- 8) Leave is admissible as per CCS (Leave) Rules, 1972.
- 9) His / Her appointment in National Institute of Siddha is on whole time basis and the appointee shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
- 10) The National Institute of Siddha reserves the right not to fill any or all the posts without assigning any reason. The number of vacancies shown is only tentative.
