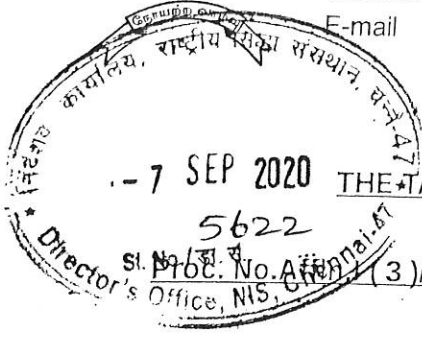

6. The provisional affiliation granted is also subject to the following conditions :-

i) Only qualified staff shall be appointed to handle the classes and the College should furnish all the teaching and other staff details with qualification; experience, date of joining etc.

ii) The Tamil Nadu Dr. M.G.R. Medical University, may inspect at any time according to the Ordinance, Rules, Regulations and Statutes for Post-graduate Siddha Degree courses framed from time to time.

iii) The ordinance, Rules, Regulations and Statutes framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of syllabus, examinations code of conduct and extra curricular activities etc., should be abided. All the norms prescribed by the Central Council of Indian Medicine/Dept of AYUSH shall also be applied by this University.

iv) The Provisional affiliation now granted by the University with the sanctioned strength should not be exceeded by 5(five) students in each branch and the maximum number of students of 30 (thirty) students without prior permission of this University and the State Govt. approval.

v) The staff pattern with prescribed qualification by the University as well as the CCIM should be followed.

vi) Facilities should be made available for conducting University Examinations.

(vii) All admission should be completed before the cut off date fixed by this University. Candidates admitted after the cut off date shall not be registered by the University.

(viii) The candidates admitted from the date of issue of this orders will take up their I M.D.(Siddha) examination as per the existing regulations of this University.

7) It is also informed that as per the Regulations for Ph.D. programme, the duration of this recognition is valid for five years and the same has to be renewed after inspection to assess the availability of the standards of the infrastructural facilities in the approved departments once in every five (5) years (Quinquennial). The Director, National Institute of Siddha, Chennai, on behalf of the Department of (i) Maruthuvam (ii) Gunapadam (iii) Sirappu Maruthuvam (iv) Kuzhandhai Maruthuvam (v) Noi Naadal and (vi) Nanju Noolum Maruthuva Neethi Noolum shall apply to this University six months before the expiry of the present recognition by remitting the prescribed inspection fee for the grant of the continuance of recognition of the said departments for the purpose of Ph.D.
