### ORDER :

The Departments of 1) Pothu Maruthuvam, (2) Gunapadam, (3) Sirappu Maruthuvam, (4) Kuzhanthai Maruthuvam, (5) Noi Naadal and (6) Nanju Maruthuvam at National Institute of Siddha, Chennai was recognized by this University vide in the reference 1<sup>st</sup> cited for a period of one year from 02.06.2014 to 01.06.2015.

2) The said recognition was renewed for a period of one year from 02.06.2015 to 01.06.2016 and further period of three years from 02.06.2016 to 01.06.2019 vide in the reference 2<sup>nd</sup> cited.

3) In the letter dated 24.04.2019, the Deputy Director, National Institute of Siddha, Chennai has remitted a total sum of Rs.4,60,200/- (Rupees Four lakhs Sixty thousand and Two hundred only) towards inspection fee of Rs.2,40,000/- (Rupees Two Lakhs and forty thousand only), renewal recognition fee of Rs.1,50,000/- (Rupees one lakh and fifty thousand only) and Rs.70,200/- (Rupees Thirty Five Thousand one hundred only) towards 18% of GST thereon, for the renewal of recognition of the Departments of 1) Pothu Maruthuvam, (2) Gunapadam, (3) Sirappu Maruthuvam, (4) Kuzhanthai Maruthuvam, (5) Noi Naadal and (6) Nanju Maruthuvam. The Deputy Director has remitted the amount of Rs.4,52,400/- (Rupees Four lakhs Fifty two thousand and Four hundred only) after deducting an amount of Rs.7,800/- (Rupees Seven thousand eight hundred only) towards 2% GST on the inspection fee and recognition fee of Rs.3,90,000/-.

5) In the 48<sup>th</sup> meeting of the Standing Academic Board held on 02.07.2014, it was resolved to authorise the Vice-Chancellor to issue further Continuance of recognition of the Department.

6) In pursuance of the recommendations of the Inspection Commission, the Continuance of Recognition is hereby granted to the Departments of 1) Pothu Maruthuvam, (2) Gunapadam, (3) Sirappu Maruthuvam, (4) Kuzhanthai Maruthuvam, (5) Noi Naadal and (6) Nanju Maruthuvam at National Institute of Siddha, Chennai for a period of three years from 02.06.2019 to 01.06.2022.

Subject: Introduction of Ph.D in National Institute of Siddha, Chennai - Reg.

Sir,

I am directed to refer to your letter No.NIS/6-30/Res./Ph.D/0910 dated 13<sup>th</sup> January 2010 on the subject mentioned above and to convey the approval of the Govt. to the introduction of Ph.D in the six subjects of Siddha in National Institute of Siddha, Chennai from the academic session 2010-11 subject to the following conditions:

- i. The Ph.D scheme should be as per the terms and conditions of Ph.D scheme available in National Institute of Ayurveda, Jaipur.
- ii. Only two Ph. D scholars in each subject of six PG Siddha Departments will be appointed each year on a transparent manner and selection of candidates should be strictly on the basis of merit based on written test with minimum qualifying marks of 55% for General and OBC candidates and 50% marks for SC/ST candidates.
- iii. The selected Scholars should be enrolled under the Institute guides recognized by the Tamil Nadu Dr. M.G.R. Medical University for pursuing Ph.D.
- iv. The rates of monthly stipend for each Ph.D scholar are as under:

a.	1 <sup>st</sup> year	Rs.18,702/- + DA as revised from time to time
b.	2 <sup>nd</sup> year	Rs.19,323/- + DA as revised from time to time
c.	3 <sup>rd</sup> year	Rs.19,323/- + DA as revised from time to time

- v. The expenditure in payment of stipend will be met from existing budget of the Institute and no additional grants for this purpose will be provided to the Institute.
- vi. This issues with the concurrence of Integrated Finance Division of this Department vide concurrence Diary No.375/2010-11 dated 13.7.2010.



Subject: - Matter relating to grant of conditional permission of the Central Government to **National Institute of Siddha, Chennai, Tamilnadu** for conducting 6 MD (Siddha) courses with 46 seats for 2009-10 academic session under section 13A of the IMCC Act, 1970.

Sir,

I am directed to refer to Department of AYUSH's letter of even number dated 10.06.2004 granting the permission of the Central Government for setting up of **National Institute of Siddha, Chennai, Tamilnadu** for conducting 6 MD (Siddha) courses with 5 seats in each specialty from session 2004-05 and the letter no. R. 13013/1/2008-EP dated 22.08.2008 for creation of 16 additional seats in PG course to implement 27% OBC reservation under section 13A of IMCC Act from 2008-09. It was stipulated in the orders of the Central Govt. that the college administration will ensure that sufficient qualified teachers in each Department, as per the relevant CCIM regulations.

2. The CCIM had carried out an inspection of your college on 12.02.2009 to assess the availability of infrastructure and staff as per requirement of CCIM norms. After careful consideration of the recommendations and inspection report of the CCIM in terms of the IMCC Act and relevant Regulations and norms of the CCIM, it is found that the College is fulfilling the minimum requirements of 80% teaching staff, 150 bedded hospital, 100 patients per day in OPD and 40% bed occupancy in IPD. It has, therefore, been decided to grant conditional permission to **National Institute of Siddha, Chennai, Tamilnadu** for conducting 6 MD (Siddha) courses with 46 seats namely (i) Maruthuvam (8 seats), (ii) Gunapadam (8 seats) (iii) Sirappu (8 seats) (iv) Maruthuvam Kuzhandai (8 seats) (v) Maruthuvam Noi Nadal (7 seats) and (vi) Nanju Noolum Maruthuva Needhi Noolum (7 seats) for the session 2009-10 subject to the rectification of the following deficiency by the end of November, 2009, failing which the permission may be withdrawn:


- (i) More teaching staff should be appointed to bring at par with the norms of the CCIM.

3. The compliance report on rectification of above mentioned shortcoming may be submitted to CCIM with a copy to Department of AYUSH by 30-11-2009 positively.
4. The fulfillment of the conditions attached to the permission given above may be made within the time period specified. The CCIM will verify that the conditions have been fulfilled by means of *suo moto* inspection and submit a report in the matter to the Department of AYUSH. Non-fulfillment of the conditions attached to the permission within the time specified may entail withdrawal of permission.
5. This issues with the approval of competent authority.





