- 2. As on the last date of receipt of application, the candidates should not exceed the maximum age prescribed for the post.
- 3. Persons working in a State or Central Government/autonomous organization only will be considered for the deputation post.
- 4. Mere fulfilling of the minimum prescribed qualifications and experience will not vest any rights on the candidate for being called for interview/for selection to the post.
- 5. The Institute reserves the right to cancel or modify this notification without assigning any reason.
- 6. The Institute reserves the right to shortlist candidates depending upon the no. of vacancies and application received etc., and also to decide the modalities for recruitment.
- 7. The Institute reserves the right to consider / call for interview such of those candidates, who in its opinion, are found to be eligible. No correspondence in this regard will be entertained from the candidates.
- 8. The terms and conditions of deputation will be governed by the instructions issued by the Department of Personnel and Training vide OM No.6/8/2009-Estt. (Pay II) dated 17.06.2010, OM No.2/6/2018-Estt. The persons working in a State or Central Government/autonomous organization applying for Deputation post should submit their application through proper channel along with up-to-date duly certified APARs of the last five years along with disciplinary / vigilance clearance certificates. They should also submit a certificate from the employer to the effect that the particulars furnished by the officer are correct as per the record held in the office and no case is pending or contemplated against him/her in the proforma enclosed in the application form, failing which the application is liable to be rejected.
- 10. No travelling allowance is admissible to the candidates to attend for test/interview.
