Terms and conditions

- 1. The candidates should report to this Institute by 10.30 a.m. sharp.
- 2. Latecomers will not be permitted to register their names for counseling.
- 3. The candidates who had submitted their applications for the first round of counseling but could not secure admission to the programme during the first round of counseling will be considered first on the basis of the merit list of AIAPGET 2021-22.
- 4. The names of candidates, who would be registering for the 2nd round of counseling on 21.03.2022, will be considered only after allotment of the seats to the candidates mentioned in Sl. No.3.
- 5. The Candidates who have already been admitted to the various specialties of M.D (Siddha) Programmes conducted by this Institute based on the counseling conducted by this Institute and AACCC are not eligible to appear for the 2nd round of counseling to be conducted on 21.03.2022 in this Institute.
- 6. Candidates shall bring all original certificates along with copies of the same for verification
- 7. Selected candidates shall remit the admission fee of Rs.53,475/-(Rupees Fifty three thousand four hundred and seventy five only) by way of Demand Draft drawn in favour of "The Director, National institute of Siddha" payable at Chennai.
- 8. The list of candidates who have been found ineligible by the AACCC to attend the counseling is uploaded in the Institute website. These candidates will not be permitted to register their names for the counseling.

9. The seats reserved for EWS candidates will be filled up with UR Category in the event of non-availability of EWS Candidates as per the latest directions received from AAQCC.
