#### **2.Introduction**

#### -Thirumoolar

The Siddha system of medicine has evolved with the civilizations of Mohenjadaro and Harappa in the Indus valley around 10,000 years ago. This is a contribution of the Dravidian culture, which is one of the oldest cultures, to the world. This system is said to have developed mainly by 18 Siddhars out of which the great Sage Agasthiyar is considered as the Father of Siddha Medicine. Thirumoolar, the first disciple of Agasthiyar, is believed to have taken lifetime efforts for nurturing the growth and development of the Siddha system of medicine. This system is following unique methods in preventing, treating, and restoring the health of patients. The Siddha system of medicine relies on the concepts of moral principles such as *Naalozhukkam* and moral guidance such as *Pini Anugavidhi* which is extremely relevant to our current health care system to prevent people from various life-threatening Communicable and Non–Communicable diseases. During the Covid-19 Pandemic the Siddha system of medicine was able to save the lives a number of acute, moderate and mild Covid patients through the timely application of preventive and curative medicines available in the system. The basic principle of this system is "Unave Marunthu, Marunthe Unavu", means "Food is Medicine and Medicine is Food".

#### 1. About National institute of Siddha:

The National Institute of Siddha (NIS), Chennai is the only National Institute for Siddha system of medicine set up by the Ministry of AYUSH, Government of India during 2005. The institution was dedicated to the Nation on 3<sup>rd</sup> September 2005. The Institute is striving to be a Centre of Excellence in the Siddha system of Medicine by offering Post Graduate courses (PG) in 8 Siddha disciplines and Ph.D. programmes in 6 Siddha disciplines. The Institute is also providing affordable medical care through the Ayothidoss Pandithar Hospital attached to it. The Institute undertakes several measures to promote and propagate the Siddha system of medicine. The Institute is conducting special OPDs, a tribal OPD at Kothimangalam village, Chengalpattu District and Swasthya Rakshan OPD. Swasthya Parikshan camps are being conducted at 5 places in Chengalpattu and Kanchipuram districts. This institute is taking steps to develop a curriculum to integrate the traditional science with modern science. Various research projects are underway in this Institute to validate the efficacy and safety of the Siddha formulations to enhance their acceptability.

#### 3. Aims and Objectives of the Institute:

- > To promote the growth and development of Siddha system of medicine.
- > To provide health care services to the public through Siddha system of medicine.
- > To impart the Under Graduate education in Siddha system of medicine.
- > To undertake research and dissemination.
- > To develop act as a center of excellence.

#### 4. Teaching and Research activities

This Institute is affiliated to The Tamilnadu Dr. M.G.R. Medical University, Chennai and it follows the syllabus and curriculum approved by the National Council of Indian System of Medicine (NCISM). The Institute is conducting M.D Siddha programmes in 8 specialties and Ph.D programmes in 6 Specialties. During 2022-23 the NCISM has given approval to start the Bachelor of Siddha Medicine and Surgery (BSMS) programme with an intake of 60 seats. The Institute is also conducting various research projects, internship programmes, teachers training programmes, seminars and workshops from time to time.

#### 7. Eligibility for admission

1	Admission will be conducted based on the AIAPGET-2022 Merit list, reservation norms of Govt. of India and as per the AACCC, NCISM and The Tamil Nadu Dr.MGR Medical University regulations.
2	Candidates who have been made ineligible by AACCC, due to their non-reporting to previous rounds of counseling / any other reasons are not eligible to get admission to the M.D (Siddha) programme conducted by this Institute.
3	Candidate should produce the Provisional Certificate or Degree Certificate from the recognized University and the Registration Certificate issued either in their State Council of Indian Medicine / Tamilnadu Siddha Medical Council (or) Central Council of Indian Medicine at the time of counseling.
4	Candidates from Foreign Countries should have passed BSMS Degree (awarded by Jaffna University, Sri Lanka) or any other equivalent Degree Course recognized by the Central Council of Indian Medicine, New Delhi with successful completion of Internship (CRRI).
5	The candidate should be a citizen of India (Not applicable to students from foreign countries)

#### 8. Method of Admission

Candidates who are absent for Counseling will lose their right to admission to the MD (Siddha) Programme 202-23 of this Institute.</li> <li>d. #### 10. Additional instructions to fill up reservation category seats

- 1. SC / ST Candidates should produce valid Community Certificate issued by the Competent Authority.
- 2. OBC Candidates should produce valid OBC Certificate showing their exclusion from Creamy Layer for the year 2022-23 as per the Govt. of India Notifications issued from time to time.
- 3. SC/ST/OBC candidates selected against UR seats have to submit their community certificate at the time of admission as per the AACCC norms for admission for the Academic Year 2022-23, failing which their admission cannot be processed in the system.
- EWS Candidates should produce Income and Asset Certificate issued by a competent authority in the prescribed format as given in Annexure-I of the OM No.36039/1/2019-Estt (Res) dated31<sup>st</sup>January, 2019 issued by Department of personnel & Training.

#### **11. Interchange of Reserved seats**

- 1. If the seats reserved for ST category remain unfilled due to non-availability of eligible candidates, the same would be filled up from the candidates belonging to the SC category on the basis of merit.
- 2. If the seats reserved for EWS category remain unfilled due to non-availability of eligible candidates, the same would be filled up from the candidates belonging to the UR category on the basis of merit.

#### 14. Stipend

- 1. Stipend shall be paid only to the candidates doing M.D.(S) course for the **FIRST time**. Candidates who repeat the MD (Siddha) course after discontinuation shall not be eligible to receive any stipend.
- 2. All the M.D (Siddha) students (except Foreign students) shall be paid stipend at the approved rates as per government norms. Foreign candidates will be paid stipend/scholarship as per the scheme of the concerned agency/ICCR applicable to them.
- 3. The stipend will be paid only after verification of the attendance and on the recommendation of satisfactory progress of the P.G. student by the respective Head of the Department.
- 4. If the candidate had discontinued the MD (Siddha) Course after the prescribed cutoff date of the University, they can re-apply for the MD (Siddha) Course only after two years from the date of discontinuation.
- 5. Students discontinuing the course will not be eligible for readmission. In the event of the demise of a student during the study period the stipend paid to him / her will not be recovered by the Institute.
- 6. The students joining the M.D (Siddha) Course shall execute a Notarised Bond on Non- judicial stamp paper agreeing that he/she would complete the M.D (Siddha) course within the stipulated time.
- 7. If he/she discontinues the course on his/her own accord or if his/her admission is cancelled for any reason by the Institute before completion, he/she shall return the amount of stipend received by him /her from the Institute in one lump sum along with the penalty of Rs.5.00 Lakhs (Rupees Five Lakhs only).

#### 15. Leave

1. The following types of leave are available to the M.D (Siddha) students. They will be eligible to receive their stipend during the following leave periods:

#### 16. Attendance:

Attendance in practical and theory classes as prescribed by the University and NCISM for appearing in the University examinations is mandatory.

#### **17. Anti-Ragging Policy**

The clauses of the regulations of the Tamil Nadu Dr. M.G.R. Medical University with regard to ragging are followed strictly in this Institute to implement the Anti Ragging measures.

Each student and his/her parent have to submit a written undertaking in this respect during every academic year. The same undertaking is also to be submitted online every year in the website <u>www.antiragging.in/Site/Affidavits\_Registration.aspx</u> to fulfill the online compliance of anti ragging regulations on curbing the menace of ragging in higher educational Institutions.

#### 18. Course Discontinuation / Unauthorised Absence

- 1. Unauthorized absence of the student will be treated as willful absence and no stipend shall be paid for such periods of absence. Disciplinary action, as deemed fit by the Competent Authority, including termination of the student from the course and recovery of the stipend paid and penalty prescribed above may be imposed on the student in such cases.
- 2. If the student is absent for more than 30 days without prior permission of the Competent Authority/without intimation to the Institute, such student will stand terminated automatically from the M.D (Siddha) Course without notice.
- 3. The break in study period upto three months can be condoned by the Director, National Institute of Siddha.
- 4. If the break in study period is more than 3 months but less than 18 months, the candidate should apply to the University through this Institute for condonation of the break in study.
- 5. If the break period exceeds 18 months, the candidate will be discharged from the course. He/she will have to refund the total stipend received by him/her till the date of discontinuation along with the penalty of Rs.5,00,000/- (Rupees Five Lakhs only). The fees paid by him/her till the date of discontinuation will also be forfeited.
- 6. If the students discontinue the course due to any appointment or any other job or for any other reason they have to repay the amount as follows:-

I year	Penalty of Rs. 5,00,000 + Refund of the stipend
II Year	Refund of the Stipend only
III Year	Refund of the Stipend only

- 7. If the candidate is debarred from the course for any reasons, he/she has to repay the stipend received along with the penalty of Rs.5,00,000/- (Rupees Five Lakhs only).
- 8. In addition to the above, the Institute shall adopt any notification issued by The Tamilnadu Dr. M.G.R. Medical University from time-to-time in this regard.
- 9. Any student discontinuing the M.D(Siddha) course beyond the cut-off date prescribed by the Govt. and before the commencement of the course shall have to pay penalty of Rs.5,00,000/- (Rupees Five Lakhs Only).

#### **19. Notarised Bond**

The candidates joining the M.D(Siddha) Programme of this Institute should submit a **Notarised Bond**, in Rs. 100/- (Rupees One Hundred only) Stamp Paper, in the prescribed format as given in the Annexure to this Prospectus.

#### 20. Research, Seminars and Extension Activities

Every student shall participate/present papers in the workshops/ seminars conducted in the Institute or University level. Departmental seminars will be regularly conducted and eminent scholars / medical experts would be invited to deliver guest lectures for exchange of views. All students have to compulsorily participate in such seminars and conferences. The Students are excepted to publish at least one paper in a reputed journal every year.

#### 21. Hostel

Separate hostel facilities are available for both Male and Female candidates. Accommodation will be allotted to the candidates according to the availability of the rooms. The Hostel Fees fixed from time to time by the Standing Finance Committee / Governing Council of the Institute will be collected. Students should abide the Hostel rules and the directions of the Warden and Competent Authority on all occasions.

#### 21. Enclosures to be attached with the Application Form

**A. Demand Draft for Rs.2,000/-** (Rupees Two thousand only) in case of General / OBC categories, **Rs.1,500/- for** (SC/ST/PwD) drawn from any Nationalised Bank in favour of "**The Director, National Institute of Siddha**" payable at **Chennai** towards application fee.
