DETAILED EMPLOYMENT NOTIFICATION NO : 01 / 2025

A walk-in interview will be held at 11.00 a.m. on 22.01.2025(Wednesday) in this Institute to fill up the following vacancies on Contractual basis:

A) ON CONTRACT BASIS:

1) Professor (Maruthuvam) – 1 Post (on contract) / 2) Professor (Nanju Maruthuvam) – 1 Post (on contract basis)

The Period of contract will be for a period of one year or till filling up the post on regular basis or until further orders, whichever is earlier.

A) i) Essential Educational Qualification:

Post Graduate Degree in Siddha in the concerned subject (Maruthuvam) recognized under IMCC Act, 1970 for Professor (Maruthuvam) ;

Post Graduate Degree in Siddha in the concerned subject (Nanju Maruthuvam) recognized under IMCC Act, 1970 for Professor (Nanju Maruthuvam) ;

ii) Five years of teaching experience as Reader / Associate Professor in the concerned subject or 5 years Research Experience in PB-III(Rs.15,600-39,100) with GP Rs.7,600/- with NPA.

OR

15 years combined experience in teaching as Reader / Associate Professor / Assistant Professor / Lecturer in the concerned subject or 15 years Research Experience in the pay scale of PB-III(Rs.15,600-39,100) with GP of Rs.7,600/-, Rs.6,600/- and Rs.5,400/- with NPA respectively out of which minimum 2 years in the pay scale of PB-III (Rs.15,600-39,100) with GP Rs.7,600/- with NPA.

3.Minimum five research publications indexed in index medicus or National Journals.

The Posts will be filled up as per the eligibility criteria indicated in Recruitment Rules mentioned above, failing which by adopting the experience conditions laid down by the National Commission for Indian System of Medicine as under:-

B) Essential Condition - Experience:

i) total teaching experience of ten years as regular teacher in concerned subject or five years of teaching experience as Associate Professor or Reader on regular basis in concerned subject; or

ii) total teaching experience of ten years as a regular teacher in Post graduate teaching in the concerned subject, or five years of teaching experience in Postgraduate teaching as Associate Professor or Reader on regular basis in the concerned subject; or

iii) total ten years of research experience as full-time researcher after possessing Postgraduate. degree qualification in the concerned subject on regular appointment in Research Council or Research Institutions of Central Government or State Government or Union Territory Administration or University or National Institutes or National Accreditation Board for Testing and Calibration Laboratories (NABL) accredited Laboratory having;

(A) qualified in the National Teachers Eligibility Test conducted by the National Commission for Indian System of Medicine; and

(B) minimum five research papers published in indexed journals (indexed in UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus); or

minimum three research papers published in indexed journals (indexed in UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus) and one published book or manual relevant to Siddha; or

investigator for any major research project with a duration of the project three years and above as per the sanctioned letter.

Provided that the in-service candidate shall have completed his post-graduate in concerned subject before the completion of forty-five years of his age.

C) The candidates should possess Teacher Code as per NCISM norms or should have passed in NTET Exam.

D) Maximum Age Limit: i) Should not be more than 60 years of age as on the date of walk-in-interview.

ii) Should not be more than 65 years of age for the **retired teachers**, as on the date of walk-in-interview.

E) Consolidated Pay :Rs.75,000/- p.m.

3) Assistant Professor (Siddha Maruthuva Adippadai Thathuvangalum Varalaarum) – 1 Post (on contract basis)

- a. The period of contract will be one (1) year or till creation of regular post, whichever is earlier.
- b. The posting of the candidate will be as per college requirements.

a) i) Essential Qualification:

1. PG Degree in Siddha in the concerned subject (Noi Naadal / Maruthuvam) included recognized under IMCC Act, 1970.
2. Teacher Code as per NCISM norms or should have passed in NTET Exam.

ii) Desirable:

1. Publication and experience in research
2. Working knowledge of Computers

b) Maximum Age Limit:

- i) No teaching experience shall be required but, the age should not be more than 45 years at the time of first appointment.
- ii) Should not be more than 60 years of age as on the date of walk-in-interview.
- iii) Should not be more than 65 years of age for the **retired teachers**, as on the date of walk-in-interview.

c) Consolidated Pay: Rs.55,000/- p.m.

4) Placement Officer – 1 Post – (on contract basis)

The period of contract will be one (1) year or till creation of regular post, whichever is earlier.

(a) Essential Qualification:

Any Post Graduate Degree and above.

(b) Experience:

A minimum experience of three years or above in the Academic field and placement matters

(c) Maximum Age: 55 years as on the last date of receipt of applications.

(d) Consolidated Pay : Rs.40,000/- p.m.

Terms and conditions for appointment on Contract

1. The application form can be downloaded from our website <https://nischennai.org> and the cost of application is Rs.500/-.
2. The filled up application along with the **application cost of Rs.500/-** to be paid by way of a DD drawn in favour of Director, National Institute of Siddha, payable at Chennai, together with the self attested photocopies of the certificates / testimonials of the applicant should be submitted at the time of walk-in-interview.
3. **The candidates should report at 9.00 AM in the Admin Block of this Institute on 22.01.2025 for document verification. Upon successful verification only they will be permitted to attend the walk-in-interview.**
4. **The registration of candidates will be closed at 11.00 AM. Those who report late will not be permitted to register their names.**
5. **SC/ST/Physically disabled candidates are exempted from the payment of the application fee, provided that they produce an attested copy of the community certificate / disability certificate, as is the case may be, from the Competent Authority along with the Application Form to claim for such exemption.**
6. All the Original certificates should be produced for verification.
7. The appointed candidates, **except Part time Consultants**, shall be entitled for leave as per CCS (Leave) rules.

8. The appointment of the candidates, except Part time Consultants, in this Institute will be on full time basis. Hence, the appointee shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of the contract. **This condition is not applicable in the case of Part-Time Consultants.**
9. **The appointment is purely on contractual basis. The tenure of appointment has been indicated below each post.** However, the appointment can be terminated at any time by The Director, National Institute of Siddha without assigning any reasons thereof. The appointee shall give at-least one month's notice for discontinuation failing which he / she has to pay one month's salary to this Institute in lieu of the notice period. However, the decision of the Competent Authority will be final in this regard.
10. For the posts of Part Time Consultants (Specialist) the appointment will be on part time basis. The remuneration will be fixed on hourly basis as quoted by the individual in his/her application for the post. The services of the Part Time Consultants (Specialist) will be utilized as per the decision of the Competent Authority.
11. The appointee shall not be entitled to any benefits like PF, Pension, Gratuity, Medical Treatment, Seniority, Promotion etc or any other benefits as admissible to the regular Government servants of this Institute. Non Practicing Allowance is also not admissible to any of the appointees.
12. Only consolidated Salary will be admissible. No other allowances as applicable to the Central Government servants shall be admissible.
13. The appointee shall not have any claim or right for regular appointment in the Institute by virtue of this engagement of contractual basis.
14. The Competent Authority reserves the right not to fill any or all the posts without assigning any reasons thereof. The number of vacancies shown is only tentative.
15. No TA/DA is admissible for attending the interview.
16. If any declaration or information furnished by the candidate proves to be false or if he/she is found to have wilfully suppressed any material information, he/she will be liable to be removed from service and also such other action as the Competent Authority may deem fit.
- 17. Applicants submitting incomplete applications and applications that are not supported by self-attested photocopies of certificates and testimonials will not be permitted to attend the walk-in-interview.*
