A walk-in-interview will be conducted on 21.12.2016 at 11.00 AM at National Institute of Siddha to fill up the vacancies of Professor/Associate Professor/Emergency Medical Officer/Senior Research Fellow on contract basis and one post of Yoga Teacher on part time basis. The Period of contract for the posts of Professor/Associate Professor/Emergency Medical Officer/Senior Research Fellow will be for one (1) year or till the posts are filled on regular basis whichever is earlier.

- ii) 7 years as Reader (Associate Professor) in PG teaching in the concerned subject or 12 years combined experience in PG teaching in the subject concerned (as Reader / Associate Professor / Assistant Professor) and Research & Admn.

The post is sanctioned at Virudhunagar District and involves extensive travel to rural areas of the District for screening the Anaemic adolescent age women, data collection, coordinating with Biochemistry laboratory and drug distribution. Tenure of appointment is for one year.

4. **Emergency Medical Officer** – (1 Post)

- (b) **Maximum Age:** Age not exceeding 64 years as on the last date of receipt of application.

Terms and conditions for appointment on contract basis

1. The application form can be downloaded from our website [www.nischennai.org](http://www.nischennai.org) and the cost of the application is Rs.500/-.
2. The filled in application alongwith the application cost Rs.500/= by way of DD drawn in favour of “Director, National Institute of Siddha” payable at Chennai together with the self attested photocopies of the certificate/testimonials should be submitted at the time of walk-in-interview.
3. Separate application is to be submitted for each post.
4. Original certificates to be produced at the time of interview
5. Self-attested copies of all requisite certificate & service / experience certificates should be attached with the application.
6. The appointment is purely on contract basis for a period of one year or till the regular posts are filled up on regular basis whichever is earlier. However the appointment can be terminated at any time on either side by giving one month’s notice or by paying one month’s salary without assigning any reason.
7. The appointee shall not be entitled to any benefit like PF, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc or any other benefits as admissible to the regular Government servants. Non practicing allowance is not admissible.
8. The appointee shall not be granted any claim or right for regular appointment in the Institute.
9. Only consolidated salary will be admissible. No other allowances as applicable to Central Government servants shall be admissible.
10. The appointment in the Institute is on whole time basis and the appointee shall not accept any other appointment, paid or otherwise and shall not engage himself / herself in private practice of any kind during the period of contract.
11. The National Institute of Siddha reserves the right to not to fill any or all the posts without assigning any reason. The number of vacancies shown is only tentative.
12. No TA / DA is admissible for attending the interview.
13. If any declaration or information furnished by the candidate proves to be false or if he / she is found to have wilfully suppressed any material information he / she will be liable to removal from service and also such other action as the Government may deem necessary.
