The candidates should report at 9.00 AM in the Admin Block of this Institute on 28.09.2019 and the registration will be closed at 11.00 AM. Those who report thereafter will not be considered.

**(i) Programme Assistant for Peripheral Pharmacovigilance Centres- 04 Posts – on contractual basis**

The period of contract will be initially for four (4) months and likely to be continued based on the approval of project scheme and satisfactory performance of the incumbent.

**Essential Qualification**

BSMS Degree recognized under Schedule II Central Council of Indian Medicine Act, 1970 from recognized University.

**Desirable:**

- 3) Preference will be given to the candidates residing at nearby area of the place of posting.

**Terms and conditions for appointment on contract basis for the post of S.No.(i) to (iii)**

- 2) The filled in application along with the application cost of Rs.500/- by way of DD drawn in favour of Director, National Institute of Siddha payable at Chennai together with the self attested photocopies of the certificate/ testimonials should be submitted at the time of walk-in-interview.
- 3) SC/ST candidates are exempted from application fee and they should produce an attested copy of the community certificate from the competent authority along with the application form to claim for application fee exemption.
- 4) Original certificates should be produced at the time of interview.
- 5) The appointment is purely on contract basis for the period of contract mentioned against each post. However the appointment can be terminated at any time by the Director, National Institute of Siddha. The appointee shall give at-least one month's notice for discontinuation.
- 6) The appointee shall not be entitled to any benefit like PF, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc or any other benefits as admissible to the regular Government servants. Non practicing allowance is not admissible.
- 7) The appointee shall not have any claim or right for regular appointment in the Institute.
- 8) Only consolidated salary will be admissible. No other allowances as applicable to Central Government Servants shall be admissible.

- 9) Leave is admissible as per rules for the posts S.No.(ii) and (iii).
- 10) His / Her appointment in National Institute of Siddha is on whole time basis and the appointee shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
