A walk-in interview will be held at 11.00 AM onwards on 03.03.2021 at National Institute of Siddha, Tambaram Sanatorium, Chennai – 600 047 to fill up the following posts on contract /part time basis.

#### **I. Professor**

##### **1) Professor –PothuMaruthuvam - 01 Post – On Contract**

The period of contract will be one (1) year or till the post filled up on promotion basis, whichever is earlier.

#### **Essential Qualification**

1. Post Graduate Degree in Siddha in the concerned subject recognised under IMCC Act, 1970
2. Five years of teaching experience as Reader/Associate Professor in the concerned subject or 5 years Research Experience in PB –III (Rs.15,600 – 39,100) with GP Rs.7,600/- with NPA

OR

15 years combined experience in teaching as Reader/Associate Professor/Assistant Professor/Lecturer in the concerned subject or 15 years Research Experience in the pay scale of PB –III (Rs.15,600 -39,100) with GP of 7,600/-, Rs.6,600/- and Rs.5,400/- with NPA respectively out of which minimum 2 years in the pay scale of PB-III (Rs.15,600-39,100) with GP Rs.7,600/- with NPA.

3. Minimum five research publications indexed in index medicus or National Journals.

*The posts will be filled up as per eligibility criteria indicated in Recruitment Rules mentioned above, failing which by adopting the experience conditions laid down by the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulation, 2016 as under:*

*Total Teaching experience of Ten years is concerned subject or Five years teaching experience as Associate Professor (Reader) in concerned subject or total ten years research experience in regular service in Research Councils of Central Government or State Government or Union territory or University or National Institutions with not less than five papers published in a recognised journal.*

**IV . House Officer – 1 Post- On Contract basis**

The period of contract will be one year.

- **Educational Qualification** : A minimum qualification of BSMS degree, with P.G Degree in Siddha or any basic medical science
- **Maximum Age**: As per CCIM norms
- **Emolument** : Rs.30,000/- per Month

**V. Medical Officer (anticipated vacancy) (Kothimangalam- Tribal OPD) –1 Post - On Contract basis**

The period of contract will be one year.

- **Educational Qualification** : A minimum qualification of BSMS degree, with P.G Degree in Siddha or any basic medical science
- **Maximum Age**: As per CCIM norms
- **Emolument** : Rs.30,000/- per Month

The engagement of Medical Officer will be in the OPD unit at Kothimangalam Village, Kanchipuram District on contract basis for a period of One Year. The duty hours are from 8.00 AM to 4 PM for six days in a week. Public holidays, as declared by the Central Government for the Central Government Offices located in Tamil Nadu will be applicable

**Terms and conditions for appointment on contract /part time basis**

- 1) The application form can be downloaded from our website [www.nischennai.org](http://www.nischennai.org) and the cost of application is Rs.500/-.
- 2) The filled in application along with the application cost of Rs.500/- by way of DD drawn in favour of Director, National Institute of Siddha payable at Chennai together with the self attested photocopies of the certificate/ testimonials should be submitted at the time of walk-in-interview. The candidates should report at 10.00 AM in the Admin Block of this Institute on 03.03.2021 and the registration will be closed at 11.00 AM. Those who report thereafter will not be considered.
- 3) SC/ST and Physically disabled candidates are exempted from application fee provided that they should produce an attested copy of the community certificate and disability certificate respectively from the competent authority along with the application form to claim for application fee exemption.
- 4) Original certificates should be produced at the time of interview
- 5) The appointed candidates shall be entitled for leave as per CCS (Leave) rules.
- 6) His / Her appointment in National Institute of Siddha is on whole time basis and the appointee shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract
- 7) The appointment is purely on contract basis. The period of tenure have been indicated against each post. However the appointment can be terminated at any time by The Director, National Institute of Siddha. The appointee shall give at-least one month's notice for discontinuation.
- 8) The appointment of Yoga Expert will be on part time basis and their remuneration will be fixed on hourly basis as quoted by the individual in their application for the posts. Their services will be utilized as per the decision of Director, National Institute of Siddha
- 9) The appointee shall not be entitled to any benefit like PF, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc or any other benefits as admissible to the regular Government servants. Non practicing allowance is not admissible.
- 10) The appointee shall not have any claim or right for regular appointment in the Institute.
- 11) Only consolidated salary will be admissible. No other allowances as applicable to Central Government Servants shall be admissible.
